#### HIGHER LEVEL STEWARDSHIP and ENTRY LEVEL STEWARDSHIP AGREEMENT

- I wrote to NE (and RPA) indicating we are still 6 months payments in arrears, up to December 2017.
   A general letter has been received indicating the inevitable changes to the setup of Natural England.
   So far as the 2017 payments are concerned they claim that the initial payments of 75% will soon be completed and the residual 25% payment for 2017 will be received by 30 June 2018. We have received 50% so will watch out for the next payment to see what arrives.
   It is apparent that NE/RPA have changed the payment scheme.
   Initially we received a sum of £762 as payment for 25.4 hectares at £30 per hectare. This was the whole
  - Initially we received a sum of £762 as payment for 25.4 hectares at £30 per hectare. This was the whole land area covered by the Agreement. It now appears that payment will only be made for 23.41 hectares (£702.30) for that land which ELS supplements for haymaking, fen restoration, grassland maintenance and grazing. The basic payment has always been allocated on a percentage basis. The revised area means some landowners will lose out and others gain, depending on how much of their land is now included.
- 2. A Rural Payments Agency payment of £4,548.45 representing ELS payments for 9 months has been received and distributed.

#### **ENGLISH WOODLAND GRANT SCHEME**

3. Nothing to report

#### **AONB PARTNERSHIP GRANT FUND**

3. Refer to Adrian's Report for present year's information and comments on working of scheme. The annual payment of £2,500 has been transferred into the Grant Fund Reserve within the Accounts. Grants approved to Arnside Archive and Swifts in the Community of £1,000 and £300 respectively have been paid.

#### **WARTON MIRES**

4. Funds are now in place for this land purchase. The Trust solicitors have been instructed and we await confirmation as to when completion is to take place. We have received documentation from the solicitors outlining the terms and fees of their actions on behalf of the Trust. These have been distributed to all Trustee

#### **COLDWELL PROJECT**

- **5.** Agreement has been reached with Mr Gardiner over the terms of purchase. Our solicitors have been instructed and they advise a valuation should be obtained. This has been obtained from Daniel Willis.
- 6. A new bank account for the receipt of donations, and loans, has been opened in the name of The Arnside/Silverdale AONB Landscape Trust Coldwell Project. All funds paid into the 'My Donate' scheme will be paid into this account. We have received documentation from the solicitors outlining the terms and fees of their actions on behalf of the Trust. These have been distributed to all Trustees
- 7. The total legal cost of purchasing the two pieces of land will be in the region of £5,400.

#### **OTHER MATTERS**

- 8. The Annual Accounts for 2017/2018 have been Independently Examined and a copy attached for the Trustees to approved and the Chairman to sign.
- 9. A proposed Budget for 2018/2019 forms part of this Report.
- 10. The £103 annual subscription to the National Association for AONBs has been paid, being an increase from last year following the NAAONB decision to increase subscriptions by the cost of living. (It is understood that the AONB Partnership, as they like to call themselves nowadays {previously the AONB Unit] pays over £2,000.
- 11. The Spring Lecture saw the Trust sell £15.70 of its own goods. We also sold 45 Geotrails (gross £128) and have received £9 in Commission, a £20 donation from Refreshments sold and £4.50 from a donation.

#### Treasurer's Report - Funds

The Landscape Trust holds the following funds.

- (i) A general unrestricted fund used for normal day-to-day transactions using National Westminster Bank plc. and Santander Bank.
- (ii) Restricted Funds for amounts held for
  - i) aa partnerand Administrator of the Entry Stewardship Agreement, and
  - ii) funds designated for a specific purpose, and
  - iii) for books sold on behalf of the AONB unit.
  - iv) There is a further Restricted Fund relating to the AONB Partnership Grant Fund shown separately.
  - v) The Entry Level Stewardship agreement began on 1st December 2013 and ends in 2023.

The Landscape Trust is providing the link with Natural England and acting as agent for the submission of claims, and receiver and distributor of payments under the Scheme for the eight landowners involved.

The Agreement allows for an annual land management payment payable half-yearly in June and December until 2023.

A Woodland Improvement Grant has been awarded for work at Teddy Heights.

All Income is held in a Trust Reserves designated Fund shown in the Accounts

The Trust's Financial Reserves are held in Short-term Deposit Accounts to enable land purchases at short notice; and/or to meet any shortfall between Income and Expenditure with Cumberland Building Society and Nationwide Building Society.

#### **Budgets**

A Budget was approved for the Reserves Committee of £5,000 for 2017/2018 the expenditure of £3,817 coming from the funds held in the Financial Reserve Fund from the HLS/ELS/EWGS schemes.

The Events were granted a Budget of £2,000. (net cost £1,075 for the year).

#### Report

The Trust made a surplus on its General activities of £8,620 for the year 1<sup>st</sup> April 2017 to 31<sup>st</sup> March 2018 after allowing for Contingent Liabilities, Prepayments and Debtors. It is not intended to seek an increase in subscriptions for 2018/2019.

The Higher Level Scheme Capital Projects work has been completed.

The Entry Level Scheme Agreement continues until November 2023. This year £2,982.38 has been paid by the Rural Payments Agency and distributed to the 8 landowners who are signatories to the Agreement. Payment from RPA are in arrears. A payment under the Woodland Development Agreement of £4,146.15 was received and has been applied to the Estates Management funds.

The Trust has a holding in the Bittern Countryside Community Interest Company of 1,020 ordinary £1 shares. No dividend was paid during the past twelve months.

Gift Aid claimable for subscriptions and donations paid between 6 April 2017 and 5 April 2018 will be received during the 2018/19 financial year. It is anticipated that this will amount to approximately £2,100 (2016/2017 - £2,254).

At the year end the Trust had debtors of £667.50 (Advertising fees invoiced 1 March 2018).

The Arnside & Silverdale AONB Partnership Grant Fund was set up in 2016 with equal funds from AONB and the Landscape Trust totalling £5,000.

During the year £6,600 has been committed of which £4,700 has been paid out on 4 Grants. The Trust will ensure that the same amount of grant funding is available in 2018/2019.

The Trust is committed to the purchase of 3.75 acres at Warton Mires from the Royal Society for the Protection of Bird for £70,000.

The Trust is committed to the purchase of 10 acres at Coldwell for £109,000.- this will be partly finance by the generosity of individual lenders who have supported the Trust with interest free loans.

The Trust has contracted to finance a re-issue of the book 'Kendal's Port' for £1,326.
